A gathering of Oregon nursing workforce leaders to offer timely updates and share insights from peers and stakeholders.

Nursing Workforce

Compensating Preceptors: Huddlers discussed how organizations can financially reward and support nurses serving as preceptors. The conversation highlighted numerous ways employers compensate preceptor work, including hourly differentials and lump sum bonuses. Huddlers agreed that a preceptor shift often includes training on key workplace technologies and processes. In addition, we discussed the burnout that can come with precepting regularly, as well as the struggle to balance employee time with the demand for clinical placement.

Updates from the Oregon State Board of Nursing: OSBN is hard at work addressing nursing issues throughout the state. Executive Director Rachel Prusak shared that the board is responding to media inquiries regarding recent allegations of an Oregon nurse. OSBN reminds our community that while these cases attract media attention, details of all investigations are confidential, and limited information can be shared with the public. In addition, OSBN reports that it is caught up on license applications and fingerprinting. Team members are evaluating current processes and working to lay a foundation for continued improvement.

Nurse Practice Act Updates: Huddlers heard about the following updates and opportunities to get involved. Please refer to the OSBN website for additional information about these meetings.

- Division 47: Following another meeting, the RAC plans to present its progress to OSBN board members in January. Potential changes would be implemented in the summer.
