A gathering of Oregon nursing workforce leaders to offer timely updates and share insights from peers and stakeholders.

Nursing Workforce

Newly Approved COVID-19 Vaccine: The U.S. Food and Drug Administration approved <u>an updated</u> <u>COVID-19 vaccination</u> that offers better protection against current variations of the coronavirus. Huddlers discussed that many employers have forgone COVID-19 vaccination requirements this year but mandate influenza vaccinations amongst team members.

The Role of Nurse Coaches: Huddlers discussed the growing popularity of nurse coaches and their role in patient care and nurse wellness. Huddlers agreed that nurse coaching training can improve patient communication and enhance health promotion. Coaching can also foster more successful behavior change efforts. In addition, Huddlers also explored how nurse coaches can support other nursing professionals with their unique understanding of nurse culture and the career challenges that can arise. As nurse coaching gains popularity, some have considered it an alternative career path away from bedside care. However, Huddlers also mused that integrating nurse coaching with bedside practice can improve patient outcomes.

Improving Morale in the Workplace: Huddlers also discussed the persistence of organizational-wide burnout and how healthcare systems address it amongst nursing staff. Nursing is a demanding career, and one attendee pointed out that the increasing complexity of patient care and acuity exacerbates stress. One Hudder pointed out that team-building events and seminars helped successfully uplift spirits and fostered team connection. Another shared that team bonding activities, such as a book club during work hours, were fun and beneficial. However, the conversation underlined that constant workload often forces them to sacrifice essential activities like socialization and team building, even though these elements are crucial for building relationships and resilience. Huddlers agreed that employers must intentionally carve out time for team-focused activities to combat this.
